**SUBJECT: RESOLUTION AUTHORIZING CONTINUING LEVY OF SPECIAL TAXES
WITHIN COMMUNITY FACILITIES DISTRICT 2006-1 (LYTLE CREEK NORTH)**

RECOMMENDATION(S)

Adopt a **Resolution No. 2015-131** authorizing the continuing levy of special taxes within Community Facilities District 2006-1 (Lytle Creek North), as detailed in Exhibit "A" to finance services and facilities and direct the Auditor-Controller/Treasurer/Tax Collector to place the special taxes on the 2015-16 Tax Roll.

BOARD OF SUPERVISORS COUNTY GOALS AND OBJECTIVES

Operate in a Fiscally-Responsible and Business-Like Manner.

- Promote public/private collaboration and projects that help to meet the needs of county residents.

FINANCIAL IMPACT

Approval of this item will not result in the use of Discretionary General Funding (Net County Cost). The special taxes will be placed on the 2015-16 property tax bills of 1,088 developed parcels within Community Facilities District 2006-1 - Lytle Creek North (CFD 2006-1) in the total amount of \$2,245,236.32. The special taxes will pay the financing for public infrastructure, for ongoing services for open space, flood and storm drain protection, and fire protection, and the County's administrative costs.

BACKGROUND INFORMATION

The Special Districts Department administers the CFD 2006-1 which provides for the maintenance of open space, flood and storm drain protection and fire protection services; as well as financing for public infrastructure in the District near the Glen Helen area through the levying of special taxes. This item will authorize the continuing levy of the special taxes (as detailed in Exhibit "A") and direct the placement of the special taxes on the 2015-16 property tax bills of the parcels within the District.

This action meets the stated goal of operating in a fiscally-responsible manner as it authorizes the levy of special taxes on the property tax bills of the developed parcels within CFD 2006-1 for the purposes of providing services to CFD 2006-1.

There are currently four improvement areas in CFD 2006-1 and each area has a Board-approved Rate and Method of Apportionment which sets the special tax for the parcels within each area. Each Rate and Method of Apportionment for the areas was approved with the initial approval of the special tax and the annual calculation of the special taxes is provided by CFD 2006-01 special tax consultant, David Taussig & Associates, using the Rate and Method of Apportionment.

**A RESOLUTION OF THE BOARD OF SUPERVISORS
OF THE COUNTY OF SAN BERNARDINO LEVYING
SPECIAL TAXES WITHIN COUNTY OF SAN
BERNARDINO COMMUNITY FACILITIES DISTRICT
NO. 2006-1 (LYTLE CREEK NORTH)**

WHEREAS, the Board of Supervisors (the “Board of Supervisors”) of the County of San Bernardino (the “County”) has formed County of San Bernardino Community Facilities District No. 2006-1 (Lytle Creek North) (the “Community Facilities District”) and designated portions of the Community Facilities District as improvement areas (each an “Improvement Area”) known as “Improvement Area No. 1 of County of San Bernardino Community Facilities District No. 2006-1 (Lytle Creek North)” (“Improvement Area No. 1”), “Improvement Area M of County of San Bernardino Community Facilities District No. 2006-1 (Lytle Creek North)” (“Improvement Area M”), “Improvement Area No. 2 of County of San Bernardino Community Facilities District No. 2006-1 (Lytle Creek North)” (“Improvement Area No. 2”), “Improvement Area No. 3 of County of San Bernardino Community Facilities District No. 2006-1 (Lytle Creek North)” (“Improvement Area No. 3”) and “Improvement Area No. 4 of County of San Bernardino Community Facilities District No. 2006-1 (Lytle Creek North)” (“Improvement Area No. 4”) under and pursuant to the Mello-Roos Community Facilities Act of 1982 (the “Act”);

WHEREAS, the Board of Supervisors, as the legislative body of the Community Facilities District, is authorized under the Act to levy certain special taxes within the Community Facilities District to pay for certain public services and to levy certain special taxes within said Improvement Areas to pay for the costs of certain public facilities (the “Special Taxes”);

WHEREAS, the Board of Supervisors, pursuant to Ordinance No. 4016, adopted by the Board of Supervisors of the County on March 20, 2007, authorized and levied the Special Taxes within the Community Facilities District and Improvement Area No. 1, as applicable;

WHEREAS, the Board of Supervisors, pursuant to Ordinance No. 4138, adopted by the Board of Supervisors of the County on March 15, 2011, authorized and levied the Special Taxes within the Community Facilities District and Improvement Area No. 2, as applicable;

WHEREAS, the Board of Supervisors, pursuant to Ordinance No. 4192, adopted by the Board of Supervisors of the County on January 29, 2013, authorized and levied the Special Taxes within the Community Facilities District and Improvement Area No. 3, as applicable;

WHEREAS, the Board of Supervisors, pursuant to Ordinance No. 4248, adopted by the Board of Supervisors of the County on June 3, 2014, authorized and levied the Special Taxes within the Community Facilities District and Improvement Area No. 4, as applicable;

WHEREAS, Section 53340 of the Act provides that the legislative body of a community facilities district may provide, by resolution, for the levy of the special tax in the current year or future tax years at the same rate or at a lower rate than the rate provided by ordinance, if the resolution is adopted and a certified list of all parcels subject to the special tax levy including the amount of the tax to be levied on each parcel for the applicable tax year, is filed by the clerk or other official designated by the legislative body with the county auditor on or before the 10th day of August of that tax year; and

WHEREAS, the Board of Supervisors desires to levy the Special Taxes within the Community Facilities District and said Improvement Areas, as applicable, for Fiscal Year 2015-16.

NOW, THEREFORE, BE IT RESOLVED by the Board of Supervisors of the County of San Bernardino as follows:

Section 1. All of the above recitals are true and correct.

Section 2. The Board of Supervisors hereby levies the Special Taxes for the Fiscal Year 2015-16 at the rates and with respect to the parcels as set forth in Exhibit A hereto. The Director of Special Districts Department of the County is hereby authorized and directed to file with the San Bernardino County Auditor-Controller/Treasurer/Tax Collector no later than August 10, 2015, a certified list of all parcels subject to the Special Tax levy including the amount of the Special Taxes to be levied on each parcel for Fiscal Year 2015-16.

Section 3. The officers and agents of the County are, and each of them hereby is, authorized and directed to execute and deliver any and all documents and instruments and to do and cause to be done any and all acts and things necessary or proper for carrying out the levy of the Special Taxes for Fiscal Year 2015-16 as provided in this Resolution.

Section 4. All actions heretofore taken by the officers and agents of the County with respect to the levy of the Special Taxes for Fiscal Year 2015-16 are hereby approved, confirmed and ratified.

Section 5. This Resolution shall take effect immediately upon its adoption.
