#### AMENDMENT TO NOTICE OF SPECIAL TAX LIEN

COMMUNITY FACILITIES DISTRICT NO. 2002-2 (CENTRAL VALLEY FPD- FIRE PROTECTION SERVICES) COUNTY OF SAN BERNARDINO

### Annexation No. 3

Pursuant to the requirements of Section 3117.5 of the Streets and Highways Code and Section 53339.8 of the Government Code, the undersigned, as the Clerk of the Board of Supervisors of the County of San Bernardino (the "County"), hereby gives notice that a lien is hereby imposed upon the parcel or parcels listed in Exhibit A attached hereto to secure payment of a special tax which the Board of Supervisors of the County is authorized to levy. The special tax secured by this lien is authorized to be levied for the purpose of financing a portion of the cost of fire protection services and the administrative expenses to be incurred by the County in the course of administering Community Facilities District No. 2002-2 (Central Valley FPD – Fire Protection Services) ("CFD No. 2002-2").

The original Notice of Special Tax Lien respecting CFD No. 2002-2 was recorded in the office of the County Recorder of the County of San Bernardino on August 20, 2002, as Document No. 2002-0435816, and reference is hereby made to the provisions of and the exhibits to the original Notice of Special Tax Lien, all of which are applicable to the parcel or parcels listed in Exhibit A and all of which are incorporated herein by this reference. The purpose of this Amendment is to simply extend the lien of the original Notice of Special Tax Lien to the parcel or parcels listed in Exhibit A hereto.

The territory of CFD No. 2002-2, as originally established at the time of formation of CFD No. 2002-2 in 2002, is set forth in the boundary map of CFD No. 2002-2 recorded in the office of the San Bernardino County Recorder on August 20, 2002, in Book 74 of Maps of Assessment and Community Facilities Districts, at page 81 and as Instrument No. 2002-0435769. The territory which is added to CFD No. 2002-2 by this Annexation No. 3 is set forth in "Annexation Map No. 3 to County of San Bernardino Community Facilities District No. 2002-2 (Central Valley FPD – Fire Protection Services), County of San Bernardino, State of California," which has been recorded in the office of the San Bernardino County Recorder on October 4, 2007, in Book 83 of Maps of Assessment and Community Facilities Districts, at page 32 as Instrument No. 2007-565300 (the "Annexation Map No. 3).

The special tax is authorized to be levied on the taxable parcels within CFD No. 2002-2, which taxable parcels now include the parcel or parcels listed in Exhibit A. The lien of the special tax is a continuing lien which shall secure each annual levy of the special tax and which shall continue in force and effect until the special tax obligation is prepaid, permanently satisfied, and canceled in accordance with law or until the special tax ceases to be levied and a notice of cessation of special tax is recorded in accordance with Section 53330.5 of the Government Code.

The rate, method of apportionment, and manner of collection of the authorized special tax for CFD No. 2002-2 (the "Rate and Method of Apportionment") is shown on Exhibit B attached to the original Notice of Special Tax Lien. The conditions under which the obligation to pay the special tax may be prepaid and permanently satisfied and the lien of the special tax canceled and the procedures for calculating the amount required for prepayment of the special tax are set forth in Section H of the Rate and Method of Apportionment.

## Additional Parcel Subject to the Special Tax
