Mojave Water Agency (MWA), as the water supply wholesaler, provided the following data regarding water supply availability over the next three years should the drought conditions continue. The data also shows the aggregate water supply demand for all water supply retailers who receive their water from MWA. As indicated, there are sufficient water supply reserves (shown as "Pre-stored SWP Supply") to offset the shortfall of water using only *annual supply* of water compared to expected demand.
