County Service Area 70 R-5 (Sugarloaf) Berm Removal Program

Dear Resident:

For the past several years, San Bernardino County Department of Public Works, Special Districts has offered a snow berm removal program to eligible applicants within County Service Area R-5 (Sugarloaf). This year's reimbursement program again will be offered for the upcoming winter season (December 1, 2022, through April 1, 2023). In order to qualify for reimbursement, all members of the household must be over age 65 or have a qualifying disability. In addition, to be eligible for reimbursement, you must also meet the annual household low income (before taxes) requirement as specified in the application. You must pre-register on or before November 1, 2022. Applications will be reviewed for eligibility into the program.

How it Works

During the course of the 2022-23 winter season, approved applicants may hire a contractor(s), including from the list below, as needed. Save your receipts and send the receipts into Special Districts on or before May 1, 2023, for reimbursement. Reimbursement for snow berm removal will be paid to approved applicants up to the allocated amount of \$250 per approved applicant.

Although the department does not endorse a specific contractor, the following is a list of contactors in your area that can be hired to remove the snow berm from your driveway:
